2. CNG Services – Low carbon innovation in the gas industry

John Baldwin from CNG Services presented an overview CNG Services www.cngservices.co.uk and low carbon innovation in the gas industry (see attached) including:

- Biomethane
- CNG for trucks
- Green Gas Certificates
- Shale gas developments

Biomethane injection to grid, growing dynamic market - first commercial project in UK 2012, 20 projects by end 2014. Biomethane is ideal way for hauliers to reduce their carbon footprint ~60%. CNG can offer significant costs savings for commercial truck operators.

3. **Business Development Programme**

Robin Rison from Winning Moves presented an overview of the Business Development Programme and the additional support which available for Solihull businesses to access the grant funding programme - see attached.

Grant funding of £10,000 - £15,000, representing 45% of the total project costs. Jobs must be created/safeguarded as a direct result of the project implementation. Eligible costs include:

- Rent and rates associated with new premises
- Installation (heating, lighting and cabling) as part of relocation/expansion
- Marketing and branding
- Signage

Open to SMEs within eligible sectors, within the Greater Birmingham and Solihull Local Enterprise Partnership area – for further information visit www.birmingham.gov.uk/bdp

Also part of the programme is a coaching and mentoring programme, **Great 200 Leaders** - www.winningmoves.com/G200L. 200 business owners and directors have the opportunity to enroll on the 12 month programme, delivering 100 hours of support including:

- Leadership development plan
- 10 peer group workshops led by industry specialists
- One-to-one executive development
- Access to board level experts
- Benchmark Index metrics for your company against competitors

Delegates will have a tour of the plant, following vehicle production from start to finish. Hear real life sustainability case studies from the shop floor - including how improvements have been made to the existing manufacturing processes and facilities as well as how sustainable design is being incorporated within new build projects. Topics covered will include energy efficiency and waste management.
